CAPTAINS REPORT

I was going to start by saying "As the year starts to settle in"; obviously that hasn't happened! Cyclone Oma is causing us some problems on the course. Thankfully, at time of preparing this newsletter it is slowly moving away. The damage was minimal considering what could have been, but I am sure it disrupted the golfing habits of most of our members.

This month I thought I would regurgitate some of the player responsibilities that need to be carried out to continue to improve the pace of play. Whilst I am generally happy with our "Ready golf" progress in the two years it has been in place, in reality we are only about half way to where I think we should be. I say this because of the things I still see members doing, or not doing, that would improve their individual times to complete a round of golf. I must say from the outset that although I do expect members to be aware and carry out the basics of pace of play issues, I don't expect the game to be played at a frantic pace so as not to enjoy the outing. If everybody is conscious of keeping the game moving, no one will be disadvantaged.

Before I proceed, I must say that I have played with many new partners over the last three months in order that I could see firsthand if we need to issue further reminders. This is in no way a direct incrimination of any of those players. I value their contribution.

Some pointers;

Basics

1. Keep up with the group in front of you.

2. Hit when ready, as long as it's safe to do so, regardless of your position being furthest from the hole or not.

If you seem to be lagging behind the group in front of you;

1. After putting out, leave the green (as long as one person stays with the players yet to finish), and head to the next tee block and play your shot before marking your card.

2. If you want to persist with numerous practice swings, do most of them whilst others are teeing off prior to moving into place to play your shot. Or, work out other ways to save time if you must have them. (An extra 15 seconds per hole is 4.5 mins per round.....and that's only for one player!)

3. Whilst realising that "walkers" cannot realistically keep up with "carters", they must work a little harder at doing other things to help their cause; e.g. hit first off the tee and prepare to move off as soon as other players have tee'd off. Mark your card whilst others are teeing off. Meanwhile, carters must appreciate that walkers are going to be a little slower than some of you formula one drivers, so get to your balls quicker so you play your shots whilst waiting for the walkers to get to their balls. Carters can get to look for partners lost balls quicker than walkers too.

4. The new rules allow the flag to be left in whilst putting, if you feel comfortable with that, use it, it certainly is quicker. A lot of Pro's are doing it too.

5. It's amazing how many players can have a putt whilst someone is quietly raking a bunker.

Above all else, having "Ready Golf" top of mind will greatly assist you to keep up with the group in front of you. GREENS CHAIRMAN

Dear Members, February was a blur. It went too quickly to promote old projects or begin any new ones. I guess those 2 or 3 days short of a real month make a difference.

In the words of the woman who is the centre of my universe (COMU), February has been too bloody hot and too bloody dry. I have to agree and recommend a good dose of rain to get the party started. Besides I'm really itching to see the drainage works in operation.

I said last month that the Greens committee joined with the Forward Planning Committee to set a path to develop a list of projects for the coming year. Those projects are a combination of business as usual and improvement of the great course that we have. Time is however, our enemy. Alas we just cannot make things happen overnight. Or can we?

Well, the committee has progressed a number of issues which are worthy of noting. These include;

Greens Expansion. - The Greens Superintendent with the consent of the committee has audited each green and developed a list of greens to expand. The expansions will be easy wins, where greens are widend around the perimeter, Now folks we can't do them all and we won't do them all because some greens need complete reconstruction. So if we are seriously going to give consideration to the course architect's plan developed some years ago, we should work on the greens that are minor changes at the moment. That way we are not just blindly doing expansion without a master plan in place. A priority list is being prepared for implementation.

- Bunkers- A bunker improvement plan was put to the committee this month which audited every bunker on the course. We have 34 of them? possibly more. And yes, I've been in everyone of them! (not something I'm really proud of). So the new bunker rake is in action to better prepare the bunkers however, a number will require amended drainage and reshaping. Most of this will be carried out by the greens staff. A priority list is being prepared to establish which bunkers to do first.
- Nursery Expansion This is happening to accommodate the green expansions. So we will be extending the existing green nursery at the right of the14th tee area to include about another 400 square metres of tiff-tuff turf.
- Cart Paths The committee workshopped a full course cart path strategy. The strategy provides for a cart path on every hole. Currently preliminary costs are being prepared to assist with future budget consideration. In addition a priority list of cart paths is being prepared for implementation. This is a huge and long term project however, if we are serious about accommodating motorised carts over the course then an implementation strategy is required.
- The drainage on the 4th fairway is slowly progressing. The preferred option requires some consultation and agreement with adjoining land owners. If agreement can be reached we will be able to finalise a design and progress.
- Upgraded on course toilets Members may notice that the toilet blocks have been freshly painted and renovated. This was an issue that has been raised before and action had to be taken. The Green Committee has now arranged regular cleaning and replacement of the tired internal equipment.

Other News

Peter our Greens Superintendent has taken delivery of the new bunker rake and has commenced its use. I would be interested to receive feedback from members if they are noticing the change in the bunkers due to the deeper raking.

Peter was also able to witness a demonstration of the tree root cutting attachment for the Ventrac machine. Tree root cutting has normally been included in the course maintenance budget utilising an external contractor however, with the multi-purpose benefits that the Ventrac machine brings, we are now able to undertake tree root cutting ourselves. The performance of the attachment was so impressive that the order was put in on the spot. This way we can implement a tree root management program and not have to coordinate with external suppliers every time whilst utilising the budget that was set aside for tree maintenance.

March is usually the end of the cyclone season but I wouldn't bet my house on that. We did again miss a bullet with TC Oma fizzling out however; the damage to trees and debris left on the course from the strong wind was another matter. Peter has implemented a clean-up program to address the debris. Members, your patience in the interim is appreciated. Please be careful of dropping branches in the windy conditions and report any potential dangers at the office so we can review and rectify.

No more to report this month. I look forward to receiving your written suggestions put forward on how we can further improve the course and keep our club progressing.

MANAGEMENT COMMITTEE OUTCOMES

Clarification : No such thing as Leave of Absence of membership

Over the past few years the Management Committee has received an increasing number of applications for relief of membership fees based on a necessary leave of absence or "suspension" of membership, or alternatively an ex gratia refund of fees or credit on future fees, that are not specifically provided for in our Constitution. These applications are generally based on grounds of financial hardship or exceptional circumstances (usually due to prolonged illness but increasingly we are receiving requests for consideration based on a member commencing extended travels or seeking time to convalesce etc.). As a consequence they are becoming a regular debating point at our meetings and the issues relating to exceptional hardship or health are becoming more complex. The Management Committee is obliged to act in the interests of its membership base and where appropriate extend appropriate compassion to individuals. Under Section 10 of the clubs (new) constitution a member who resigns is not entitled to a refund of membership fees paid in advance but may make an application to the Management Committee for an ex gratia refund of fees on the grounds of financial hardship or other exceptional circumstances whereupon the Management committee may at its absolute discretion grant or refuse the application. We do not receive many of these applications and they have been dealt with on a "piece meal" basis. Unfortunately, the complexity and volume of requests for suspension has led the Management Committee to review its policy relating to these matters. We are advised the same issue existed under the old constitution but it was decided <u>not</u> to include "leave of absence" or providing a credit for future fees, when drafting the new constitution.

Under our constitution, if a member does not renew their membership they are entitled to re-join at a later date (Rule 11(10)); and there is no joining fee (notwithstanding Rule 11 (11)) so members are not <u>currently</u> penalised for allowing their membership to lapse when joining again when their circumstances change). If the Constitution anticipated a process of suspending membership or providing leave of absence it would be specifically included and the circumstances prescribed. It is not. The Constitution does provide for pro-rata membership fees for joining during the year (rule 11 (12).The membership fees shall be calculated on a pro-rata monthly basis from the date of lodgment of the application for membership where the initial period of membership does not extend to a full membership year.)

Some have argued that they lose the right to lease a Cart shed if they allow their membership to lapse. This is both true and fair. There are plenty of members on the waiting list for a Cart shed and appropriately any lapsing of membership instantly cancels a Cart lease (even if prepaid). And remember, we lease Cart sheds not storage sheds ... and our Cart sheds may only be leased by members who are storing their Golf Cart (and only for their use). Suspending membership and allowing a member to retain their cart shed is effectively converting a cart shed into a storage shed (and is contrary to their permitted use).

Others wish to suspend their membership because this entitles them to maintain or preserve their Golf Australia Golflink handicap (and any associated privileges) but again, this is not contemplated in our Constitution.

After much discussion, the Management Committee has decided it can only consider refunds pursuant to a notice of resignation of member pursuant to Rule 10(3) as prescribed in our constitution. If any HBGC members seek to amend the Constitution or bylaws in future to incorporate this provision then that will be a healthy debate.
